BY MAIL: IN PERSON:	If you wish to protest in writing, please include your estimate of property value as of June 30, 2024, and any additional documentation that you believe supports a change in the classification and/or valuation of your property. Written protests must be postmarked no later than June 8, § 39-5-122(2), C.R.S. You may be required to prove that you mailed your protest on or before the June 8 deadline; therefore, we recommend that you retain proof of mailing. If you wish to protest in person, present to the Assessor's office your estimate of property value as of June 30, 2024 and a copy of any documentation that you believe supports a change in the classification and/or valuation of you property. You must appear in the office of the County Assessor no later than June 8, § 39-5-122(2), C.R.S.						
To preserve your appeal rights, your protest must be either postmarked or received by the Assessor no later than June 8 - after such date, your right to protest is lost.							
The Assessor must mail you a Notice of Determination <b>on or before the last working day in June</b> . If you disagree with the Assessor's determination, or if you do not receive a Notice of Determination, you must submit a written appeal to the County Board of Equalization <b>on or before July 15</b> if you wish to continue your appeal, § 39-8-106(1)(a) and (3), C.R.S.
